Secretary's Report

Call to order at 6:35 by Director Bill Lutz.

- 1. <u>Secretary's Report</u> revised attendance to add Dawn Miceli's name. Report accepted; motion made by A. DeBishop; seconded by B. Pestillo
- 2. <u>Treasurer's Report</u>: A. DeBishop reported recent deposits (\$750/\$150); present checking account balance (\$17,892.57). Discussion about renewal of 3 CD's coming due this summer (\$29,061.03). Alan is awaiting donation (\$1,000) from Wachovia. Treasurer's report accepted. B. Pestillo moved, seconded by G.Costanzo.
- 3. <u>Chairman's Report</u>: B. Lutz sincerely thanked Bethany Pestillo for her hard work, efforts and leadership as previous chairman. He then acknowledged Kelley Nolan-Mangione for her contributions as previous secretary and for her varied contributions to the SEF organization.

4. Grant Committee Report

a. <u>Teacher Grants</u>: G. Costanzo reported that 3 grants have been received for May deadline. Discussion followed about whether to consider a grant proposal that includes teacher payment for hours worked. Dr. Erardi indicated that this type of request should go to Professional Development at Central Office. George will contact the teacher to suggest he speak with Assist. Superintendent H. Thiery.

5. Fund Raising Committee Reports

- a. Spelling Bee: A. DeBishop chairs this committee, comprised of D.Miceli, B. Pestillo. Date is set for June 16 (Thursday) at 7:00 at SHS auditorium. Dr. Erardi and Betsy Chester will serve as the referees (who monitor the time). No admission charge. Spelling Bee: 30 teams of 3; each team will raise \$300; team name and costumes. Still need a Bee Master.
- b. <u>Drive In Night</u>: D. Miceli reported that the SEF date is June 25th.
- c. <u>Fan of the Foundation Gala</u>: B. Pestillo reported that the gala will be at Aqua Turf on October 28th (Friday) at 7:00. Letters to be sent to town groups seeking donations for this event. Committee meeting dates will be emailed. She stressed there are many areas for member involvement.
- d. <u>Bertucci's</u>: B. Pestillo has spoken with Bertucci's and they are interested in SEF fundraising. Discussion included a similar event such as previously done at the Outback. - iii. <u>Progress on STEM Proposal</u>: Discussion about STEM committee's readiness to present a concrete proposal to Mr. Robinson. G. Costanzo questioned about the importance of a more concrete proposal from the YMCA regarding building construction, maintenance, and student fees. T. Sheffy will request that Mark Pooler provide from his counsel a draft of such proposal.
- iv. <u>STEM Mission</u>: K. Freeman inquired about the stated mission and will contact M. Pooler for such information. Discussion transpired about a need for posting on SEF website. Kristen suggested that part of the STEM mission be to draw females and minorities into the sciences.

T.Sheffy who will chair committee explained that 600 tickets sold at \$50 each would virtually break even. Richard's Chevrolet will cover the cost of title and insurance and purchase tickets. Contingency contract discussed. Discussed how to sell tickets—different group of purchasers—various venues that draw a crowd (i.e. Graduation, Drive-In Night, Spelling Bee, Music on the Green, Apple Harvest, etc.). Dr. Erardi suggested that the push to sell be from present through August. In the fall the focus must be on the gala.
