- 1. **Welcome/Call to Order** Paula called the meeting to order at 6:07 p.m.
- 2. Secretary Report (Ellen)
 - a. Regular Meeting November 12, 2019
 George moved approval of the 11/12/19 minutes, seconded by Trish.
 All in favor. The minutes were approved.
 - Special Meeting December 10, 2019
 Gloria moved approval of the 1/10/19 minutes, seconded by Jan.
 All in favor. The minutes were approved.
- 3. Treasurer's Report (George)
 - a. Monthly report January, 2020 CHECKING-- \$16,831.95 SAVINGS/MONEY MARKET--\$11,528.15 BALANCE/ASSETS—\$28,360.10

 - Fundraising checks were received: \$3,000 from the Southington Drive-in, and \$280 from Just-For-You Gifts.
 - Jerry moved approval of the treasurer's report, seconded by Jan. All in favor. The treasurer's report was approved.

b. YMCA Sloper Plunge

Ellen made a motion to donate \$300 to sponsor an SEF "Ghost Team" for the Sloper Plunge. Ann seconded the motion. All in favor; the motion passed.

c. Town Spelling Bee

Gloria moved to spend \$135 to sponsor the Town-wide Spelling Bee (for the purchase of gift cards for school winners and the grand winner). Seconded by Ellen. All in favor; the motion passed. Paula, Trish, and Gloria will represent SEF at the Spelling Bee on April 6th at 7:00 at Thalberg School.

d. Visual & Fine Arts Scholarship

The plan to offer a fine arts scholarship jointly with SoCCA and SACA this year suddenly fell apart. Ann moved to return to the SEF Visual & Fine Arts Scholarship as in the past for \$1,000. Seconded by Trish. All in favor; the motion passed.
