A. Welcome/Call to Order -

Lisa called the meeting to order at 6:30 pm, and welcomed two new volunteer members – Bob Brown and Julie Portfolio.

B. Approval of June Minutes

There was an omission on the 9/12/23 minutes that had been sent out electronically. Nancy R moved to accept the minutes as corrected, seconded by Jan. The corrected minutes were approved.

C. February Treasurer's Report – Dianne Quinn

- Checking account balance = \$53,240.
- There is a leftover balance of \$491.24 in the Barnes program account.

- The \$900 privately funded grant through Main Street Foundation was paid directly to the awardee and is therefore not accounted for in our treasury.
- Paula moved to approve the treasurer's report, seconded by Jan. The motion passed unanimously.
