2. Secretary Report (Ellen)

Gail moved to approve the minutes of 3/14/18 Second - George All in favor.

3. Overview of SPS Systemic Transformation Plan

Steve Madancy presented a 3-year plan showing a new SPS vision for the future, with new applications for 21st century skills. "We need to prepare students for jobs that do not yet exist." Tony Wagner, of Harvard's Innovation Lab, explained on video why it is important for schools to move in a new direction - integrating critical thinking, communication, collaboration, and creativity (innovation) into education. The district will be networking and collaborating with *EdLeader21* to help facilitate the district's new vision.
