A. Welcome/Call to Order –

The meeting was called to order at 6:35 pm. Steve suggested a *Superintendent's Update* be added to future agendas.

B. Approval of December Minutes

There were no additions or corrections to the 12/12/23 minutes. Katie moved to accept the minutes, seconded by Jan. The minutes were approved.

C. Treasurer's Report - Dianne Quinn

- The treasurer's report was shared on Google Drive.
- Checking account balance = \$62,171.11.
- Expenses included a \$1,000 scholarship payment and a \$2,000 donation to support the robotics team.
- Income included many donations and \$471.50 from Just-For-You.
- Jerry moved to accept the treasurer's report, seconded by Paula. The motion passed.
- Paula questioned and a discussion took place about our improved treasury status and our ability to do more with it.
- Steve told us about three ideas that would need additional funding: 1)
 Continued expansion of robotics into the elementary schools with a possible park & rec. partnership. 2) Creation of a working farm on the Pleasant Street property for younger students. 3) Increasing multi-lingual resources for the growing number English language learners in our district.
- Michelle suggested that a program could be proposed and that we seek additional funding, possibly from the Main Street Foundation.

- Paula made a motion to set aside \$10,000 in seed money for a possible program grant, seconded by Katie. The motion passed unanimously.
- Paula, Katie and Steve will meet to discuss further.

D. Committee Work

1. Scholarship - Ann

- One scholarship award has been paid; the other two scholarship recipients have been reminded to submit their transcripts.
- Ann is forming a committee of readers for late March / early April.

- d. Direct Mail Fundraising Julie
 - Julie composed a fundraising letter that went out through Constant Contact on 12/21 as a test run. The timing wasn't great.
 - It will be worth pursuing a physical mailing.
 - Possibly target local businesses.
 - Interest in linking to Teacher Appreciation Week in May.
 - Jan suggested we might be able to get a grant for expenses like postage from CFGNB.
- e. <u>Cider Tasting at Rogers Orchard</u> Nancy R.
 - \circ Date is set for the evening of May 8th.
 - Nancy will connect with Bread For Life to see how their event was organized and staffed.
 - \circ $\,$ There was consensus to include a small auction at the event.
 - Justin Mirante has offered to build an Adirondack chair for the auction.
