## **Treasurers Report**

- We have a balance of \$18,073.84 in our account.
- There are some outstanding checks that need to be collected from the fundraiser.
- The Fan of the Foundation event brought in \$29,000 from ticket sales. Our expenses totaled \$14,707.42, leaving us with a profit of \$14,292.58
- Alan is working on a budget to present at our next meeting. We will allocate funds into designated accounts and begin funding mini grants.

## Fundraising

- There was a positive response from those attending the Fan of the Foundation. The board has been collecting feedback and will discuss suggestions and needed modifications for next year. Congratulations to Kelley and Joannie for organizing a very successful event!
- The Executive board was very pleased with the turn out and profit. Some concern was brought up about the low ticket sales from teachers.
- Thank You cards have been printed and will be sent out.
- The next fundraiser will be in January at the Outback. Tickets will be sold for \$25.

## Grants

- George has sent out letters to the civic organizations soliciting funds.
- George is working on the procedure and criteria for applying for a grant. The board would like to begin accepting and funding mini grants at the start of the year.

## Superintendent

- If decided upon, Dr. Erardi will discuss with the Board of Education having a liaison on the foundation board.
- The General Manager at the Outback is interested in offering a monthly recognition program for staff or student of the month.
- Dr. Erardi offered some ideas for large ticket item funding. Among those mentioned and to be discussed, was assisting the Early Childhood Collaborative and Family Resource Center, summer enrichment program, TV/radio station, Bio Bus, and FLES program (Foreign Language in the Elementary Schools).
- We will look into soliciting large foundations to help fund specific projects.
