Approval of Treasurer's Report - George

Current totals reflect receipt of a \$5,000 donation from the Quinn Foundation, donations to the Brian Goralski Scholarship and a profit of \$1527.50 from the Trivia Bee.

Chair Reports

<u>Paula</u> expressed sincere gratitude to the Quinn Foundation for their generous donation and suggested that we acknowledge their ongoing support by naming a future grant after them.

Committee Work

a) Grant Committee – Jan

Jan reviewed proposed revisions to the grant application, scoring rubric, and project evaluation forms that had previously been shared electronically with members. Discussion involved the wording of the sustainability section. It will remain unchanged.

Motion: Jan moved approval of the proposed mini-grant application, scoring rubric, and project evaluation as revised, seconded by Michelle. All in favor. The motion passed.

Motion: Jan moved approval of the SEF Grant Committee Winter/Spring 2022 Timeline, seconded by Paula. All in favor. The motion passed.

The revised grant application information will be updated on the website.

b) Program Committee Report - Michelle

- SEF continues to be the *fiduciary sponsor* of the school district's Emotional Intelligence (EI) grant from the Main Street Foundation.
- Michelle announced that \$15,000 was awarded and \$14,250 should be disbursed to the district upon receipt, minus 5% admin fee or \$750 that should be added to SEF general funds.

c) **Trivia Bee** – Jerry and Paula

- A total profit of \$1527.50 was raised after expenses.
- A discussion occurred concerning a communication received about the unexpected R-rated nature of the event. An apology will be sent.

d) **Honor an Educator** – Joyce

- Town Hall has yet to display SEF's thank-an-educator banner.
- A sign is currently on display on the town green.
- Baskets of SEF literature and goodies will be delivered to the schools next week.
- Baskets of apples, courtesy of Rogers Orchards, will also be delivered.
- Joyce will take pictures for publicity purposes.

e) Shopping Extravaganza – Paula

- Many businesses from last year committed to participate again.
- New businesses will include several at Factory Square.
- Lisa volunteered to help market the event through social media.
- There will be a mass mailing to promote electronically.
