Action: All In Favor. The minutes were approved.

Approval of Treasurer's Report - George

The February financial report includes \$559.10 from the shopping extravaganza and another \$574 for the Goralski scholarship. One of the 3 scholarship winners has not responded to requests for information from the college necessary to receive the scholarship.

Chair Reports

Committee Work

a) Board Development – Jan via Gloria

Having not heard otherwise, it is assumed that all present board members will continue next year.

b) Grant Committee – Jan via Gloria

No grant applications have been received to date. The deadline is March 1st.

c) Program Committee Report - Michelle

- Michelle reported on the Southington Public Schools' Social Justice Coalition on which she has served as a parent and SEF representative.
 The coalition is in the process of transitioning from a district-based to a community-based entity.
- The Superintendent has gotten permission to repurpose a \$10,000
 CFGNB grant to support this endeavor and is requesting the SEF serve as the "fiscal agent" or manager of funds.
- Michelle moved that SEF accept the school district's request to serve as fiscal agent for the purpose of managing the \$10,000 CFGNB grant awarded to the *Community Coalition*. Joyce seconded the motion.
- Discussion points: SEF would get to keep a small percentage (typically 3-5%) for general funds; Coalition work is aligned with the SEF's core values; and support will give SEF greater community exposure.
- Action: The motion passed unanimously.

d) **Scholarship Committee** – Susan

- Katie and Susan met to review the procedures.
- The committee presently has 6 readers and would like more.
- Ann awaits a response from one of last year's scholarship winners.

e) Marketing Committee – Lisa

A PowerPoint presentation was made to JFK, as Paula reported earlier.

f) Spring for Education Gala – May 7th

- George will order more card readers.
- George will delay the purchase of insurance until closer to the event.
- Jan has applied for a CFGNB grant for the gala.
- Joyce sent a letter to PTO presidents requesting their support of either a raffle basket or a contribution to the gala as well as attendance at the event.
- Joyce has requested a Golfing gift certificate for the raffle.

g) Honor an Educator - Joyce

- No further plans at this point.

New Business

- a) Robotics Team Request Paula

 - Paula motioned that SEF donate \$500 to the SPS Robotics Team 195, seconded by Trish.
 - Discussion points included that we still have money allocated from the first round of grants that wasn't used.
 - Action: The motion passed unanimously. George will send a check.
- b) A letter was received from friends of the Erardi family requesting support for Joe by making a donation to their Boston Marathon team, running to raise a substantial donation for cancer research. This information will be forwarded separately to all SEF members for their consideration.
