III. Projected Budget for 2022-2023 – Paula

Payables:

Operational Costs - \$2,000 – George verified sufficient given fiscal trends the last three years.

Scholarships - \$1,500 Gloria motions to increase to \$1,000 each for a total of \$3,000 that wouldn't be paid out until the 2023-2024 school year. Second – Jerry. Discussion if \$750 would be more reasonable. Typical annual revenue \$20,000, payable \$10-12,000, operational \$2-3,000, carryover \$5-8,000. 6 in favor, 4 not in favor. Motion Passes.

Mini-Grants - \$5,000 – Committee motions four grant cycles and increasing award amount from \$500 to \$1,000 per grant, and coming back to Board if additional funding needed for Spring. This would encourage earlier submissions and sooner implementation. Second – Nancy. Discussion if two grant cycles sufficient. Michelle motions to provide a Grant Writing Workshop in September/October and three grant cycles. Second – Gloria. All in Favor. Motion Passes. Grant Committee will determine dates and develop communications to be shared with district.

Program Grants - \$5,000 – Michelle verified sufficient given external foundation/community partners. (e.g, Main Street Foundation, Community Foundation for Greater New Britain, etc.).

Receivables: Trivia Bee - \$1,000 Basketball Game - \$5,000 Shopping Extravaganza - \$500 (changed) Honor an Educator - \$500 (changed)

Gala - \$12,000

Sponsor Campaign - \$5,000 (Need add to website that we are registered with Guide Star and Network for Good.)

Drive-In - \$2,000 (added)

Amazon Smiles - \$500 (Need to promote more. Ask organizations to promote a month for us. Michelle will ask Stacy Dolan of Southington Talks to pin for the summer.)
