- Michelle offered to lead a grant writing workshop intended to assist teachers with the application process. Steve suggested they might also appreciate help with generating new ideas for grants.

- Members were encouraged to visit the awarded grant section of the website.
- The grant committee will meet on November 28.

- There are 8 completed grants that could be presented.
