

**Southington Education Foundation
Board at Large Meeting
Minutes
May 28, 2013**

Vice-Chairman's Report: Jan summarized highlights of the past year. The Fan of the Foundation yielded nearly \$30,000; school grants awarded \$18,000; Spelling Bee earned \$10,000. Within the community the SEF continues to provide enrichment to fourth graders through the outdoor program at YMCA Camp Sloper as well as to heighten awareness of the educational impact of SEF grants through the Celebrating Success programs.

Committee Reports:

Communications: Jan shared Dawn's report regarding continuing press in terms of the quarterly e-newsletter, PTO announcements, publicity pieces in local media, and Facebook posts.

STEM: Tony stated we are presently involved in laying the proper foundation for the implementation of STEM. Those involved from SEF and particularly school district representatives are focused on gaining knowledge about STEM in terms of our own curriculum and programs, as well as what is out there in our state and the nation. Tony also emphasized the importance of raising awareness of what STEM actually is and how the school system and ultimately the community can benefit from STEM initiatives. Tony is using his role as Chamber president as a platform to raise STEM awareness. Tony has had the opportunity to speak with Governor Malloy and Senator Blumenthal about our STEM initiative and both stand ready to assist us when and how they can. In addition, two teachers will be attending a "STEM" conference this summer.

The **STEM Recognition Program** is a new initiative that will support and enhance those STEM related programs and projects already underway in our school system. Bill suggested informing the math and science coordinators of the STEM Recognition Program and requesting that they provide SEF with information about staff involvement in classroom initiatives for the purpose of recognition. A meeting with coordinators was discussed. Dave shared his discussion with the CCSU president and the potential of STEM support from the university.

Grant Committee: Beth P. announced that the next grant presentation will take place at JFK on June 12th. Carmela Avery is working on refreshments. Invitations have begun to go out. Beth explained that the focus of the grant process is changing and will be revised during the summer.

Fundraising Committee:

Fan of the Foundation: Kim announced the details of the October 25th Fan of the Foundation to be held in Kay's Pier North. Summer meetings will be held. Committee needs were discussed; volunteer interests were surveyed.
